PRESIDENT'S MESSAGE

As our turf farm has moved into its first harvesting and selling phase, it is perhaps timely to fill members in what this venture is all about.

Last year our Turf Farm was established as one of a number of initiatives designed to establish additional income streams for Red Cliffs Golf Club, apart from the traditional, yet still vital, member's subscriptions and bar income. With changing club demographics it was more than obvious that the club income base had to be broadened. With this in mind and limited club funds available, an equal partnership was formed between a group of twenty investors and the Red Cliffs Golf Club, to grow and sell turf. This agreement sees the investors contributing labour and funds towards irrigation, purchase of turf equipment and establishment of the business, while the club supplies the land, water, equipment and labour.

Profits from the turf farm are to be shared equally between Red Cliffs Golf Club and the investors, with a mechanism in place, which will see the investors being bought out, leaving total ownership of the turf farm and income derived from it, to the Red Cliffs Golf Club.

It is important that it is clearly understood by all members that the turf farm activities are being undertaken for the benefit of Red Cliffs Golf Club and its members through contributing to the establishment of a solid financial base for the future. The assistance of many people with the turf farm has been yet another example of the generosity of our members in a time of need. In particular, Tom's contribution has been nothing short of phenomenal, with much of his work done at weekends and after hours.

I sincerely hope that all associated with Red Cliffs Golf Club, continue to recognise and respect the contributions others amongst us make in so many different ways, as the co-operation of the various individuals, sub committees, and groups is vital to the future of your club.

THE CLUB'S FINANCES – Chris Healey

It is a mixed bag this month with a few 'smiling faces' and a few 'glum faces' to balance things out. Due to some uncertainties surrounding the validity of last year's figures, as a result of our recent computer crash it is difficult to get a handle on where we are in relation to the same time last year. Our conservative estimate is that we are approximately \$6,000.00 better off than the same time last year. The budget is basically on track with only a few minor areas of concern and our efforts to reduce debt have been good. The liquidity of the club remains good with a surplus cash balance of \$18,775.00. We had a particularly good month in May banking \$28,000.00.

I have heard a few negative comments recently about some decisions the General Committee has made regarding the expenditure of funds. I can assure all members that the finances of the club are being well managed in light of our current situation and that decisions are being taken on the basis of the budget set at the beginning of the year. The club cannot stand still and do nothing and there will be times when it will be necessary to spend money to keep the club moving forward. The task of the General Committee is to make these decisions based on a thorough examination of the financial situation and it is my task as Treasurer to ensure that the General Committee has all the facts at its disposal.

Member loans are a good way of raising much needed capital for the club, whilst providing the lender with a positive outcome. The General Committee is keen to investigate the use of member loans to finance the replacement of the automatic watering system on the course. I would be interested in talking to any member who has \$5,000.00 to invest over the next 3 to 5 years.
